Any person may apply to become a member of the Bar of the Shingle Springs Tribal Court by submitting an Application for Admission to the Tribal Court and an annual non-refundable application fee of \$50.00. Shingle Springs Tribal Attorneys and Tribal members are exempt from the application fee. The Tribal Court Judge shall also have discretion to waive fees for any applicant. The Application must contain the applicant's sworn statement that the applicant has reviewed the Tribe's statutory laws and Court rules, that applicant consents to the jurisdiction of the Tribe for all matters related to the application for admission and all other conduct by the applicant, whether before or after admission and whether by appearance, written submission, or otherwise, in the Tribal Court's administrative bounds.
